"The 1960s and 1970s are central to historic understanding of U.S. anti-rape activism, particularly in its institutional formations. The anti-violence work of these decades was deeply informed by Indigenous and Black women's activism against white supremacist sexual coercion and exploitation that extends back into U.S. settler colonialism and slavery."







## The Role of White Women During Slavery



White women have known from the beginning in this country that they possess this power, the power to activate white supremacy and spur it to extreme violence. They merely have to feign victimhood, to appear afraid and affronted, to muster a tear or a scream. The activation of white terror is a white woman's soft power.

We like to masculinize white supremacy, to presume it reeks of testosterone, when in fact, it is just as likely to be spritzed by perfume. Forty percent of slave owners were white supremacy, to presume it reeks of testosterone, when in fact, it is just as likely to be spritzed by perfume. Forty percent of slave owners were white women. It was white women who made the market for Black women's breast milk and who were attended by Black women in the big house. It was white women who upheld much of the day-to-day white supremacy—the schoolteachers, the store clerks, the waitresses. And it is now often white women activating police interactions with Black people.




# FINANCIAL OPPRESSION

To ensure that your agency is moving towards an equitable workplace model, consider practicing the following practices of open communication that are not oppressive in nature:


- **1. Open communication** with staff members around real time expenditures and/or long term budgetary goals for a given agency.
- 2. Develop a policy and implement a procedure for **regular reviews of liveable** salary/wages that champion equity.
- 3. Consider developing a survey to ask all staff what works best for them. **Staff are an incredible resource and asset who can inform best practices**.
- 4. Revisit job descriptions and revise if necessary to **ensure that the financial roles are clear** and interact with appropriate oversight.
- 5. Educate all staff of where funding sources come from and inform all staff about how agency is working to be intentional about transparent budgetary checks and balances.



# The Socioecological Model



Racism is both overt and covert. It takes two, closely related forms: individual whites acting against individual blacks, and acts by the total white community against the black community. We call these individual racism and institutional racism. The first consists of overt acts by individuals, which cause death, injury or the violent destruction of property. This type can be recorded by television cameras; it can frequently be observed in the process of commission. The second type is less overt, far more subtle, less identifiable in terms of specific individuals committing the acts. But it is no less destructive of human life. The second type originates in the operation of established and respected forces in the society, and thus receives far less public condemnation than the first type.

# The Incentives of Performing Anti-Racism

"The white liberal differs from the white conservative only in one way: the liberal is more deceitful than the conservative. The liberal is more hypocritical than the conservative. Both want power, but the white liberal is the one who has perfected the art of posing as the Negro's friend and benefactor; and by winning the friendship, allegiance, and support of the Negro, the white liberal is able to use the Negro as a pawn or tool in this political "football game" that is constantly raging between the white liberals and white conservatives.


